RE-CERTIFYING REQUIREMENT FOR CERTIFIED COLLECTORS AND TREASURERS

A Certified Individual must attend the Annual School and/or Annual Conference of the MCTA, during the same calendar year, a minimum of three years of the five years following original Certification or Certification Renewal.

During each of the three years of attending school and/or the annual meeting, a Certified Individual must take **4 courses of their choice** (for a minimum of 3 out of the 5 calendar years). Course 201 is no longer an additional requirement, although still offered virtually & encouraged.

NOTICE TO ALL TREASURERS AND COLLECTORS

The use of the designation CMMC or CMMT without having been formally Certified by the Association is strictly forbidden.

The Massachusetts Collectors and Treasurers Association Code of Ethics, paragraph (4):
